Report:

The CCEC serves as the Early Learning Council's rules advisory committee for all rules related to early learning and development programs in Oregon under its authority.

Key Issues Discussed & Uncovered:

The CCEC committee met October 13, 2016.

Early Learning Council Measuring Success Committee Report

Committee Charge:

Report:

The Measuring Success Committee met via webinar on October 25th.

1. Review draft memo for incentive metrics for Hubs and finalize recommendation for the ELC

The Committee reviewed the draft memo for the final recommendation for Hub incentive metrics to be presented at the ELC meeting. The Committee previously agreed that the incentive funds be tied to performance on a composite metric that is as simple as possible while capturing different types of indicators of progress across areas of Hub focus. The memo to be presented outlines the RFP process and backup procedure, the timeline, a recommendation for application review, scoring and allocation of funds, and the general nature of the composite metric.

Due to the necessity to ensure no applicant received an unfair advantage due to having a public meeting, and the fact that key Hub staff and partners are members of the Committee, the final recommended composite metric items were not released and may not be released until the official publication of the RFP.

KEY ISSUES DISCUSSED & UNCOVERED:

2. Develop final recommendation for the ELC for a composite incentive metric for Hubs

The following issues were considered by the Measuring Success Committee:

1. A number of members of the Committee expressed the need to emphasize that Hubs were not competing against each other for incentive funds, but against themselves. Performance of any Hub is not evaluated in comparison to any other Hub in recognition of the differential development progress and stages of the Hubs.



- 2. Concern was expressed, especially from Committee members who are also Hub staff, about the amount of work involved for the RFP application as well as the fact that the response period was in the month of December. Committee staff emphasized the low word limits for applications and that much of the required information for the application had already been prepared by the Hubs for other reports. In addition, it was emphasized by staff that this RFP process is much less arduous than the previous RFP over the same period last year. In addition, the Committee agreed to suggest the ELC push the time period back a couple of weeks to minimize required work of Hubs and ELD staff during the holiday season.
- 3. Committee members also recommended emphasizing the following in communication with the Hubs.
 - a. Recognition of a Hub's progress does consider locally-driven priorities in context with Hub metrics and the three goals of the ELD.
 - b. Language in the current RFP and in future communication should emphasize rewarding Hubs for great performance, and their progress toward long-term Hub goals.
 - c. Highlight that there will be an opportunity in the next biennium to structure true incentive metrics, and work through a timeline proactively.

The Measuring Success Committee is slated to bring its full recommendation to the Council on October 27th.
