Action Requested: Continuation of the discussion of safe transportation of child care children. Make recommendations to the Early Learning Council.

Program Summary:

The Office of Child Care licenses Certified Centers, Certified Family Child Care Homes, Registered Family Child Care Homes and monitors Regulated Subsidy child care. All types of care provide safe and healthy environments for children when in care.

Eligible Population:

Licensed child care programs and Regulated Subsidy child care programs.

Population Served:

Licensed child care programs and Regulated Subsidy child care programs.

Stakeholders Impacted:

Partners: Child Care Resource and Referral, child care unions,

Licensing: OCC licensing specialists, OCC central office staff, certified center providers, certified family child care providers, registered family child care providers, regulated subsidy providers, provider network groups, Head Start programs, Preschool Promise programs, K-12 schools, Relief Nurseries.

Consumers and other external stakeholders: parents of child care children, child care children.

Stakeholders Consulted:

Licensed child care providers. Additional stakeholder engagements are being developed and will be implemented as this review progresses. The Equity Implementation Team will be consulted as rule concepts are developed and rule language is drafted.

List of Other Interested Parties:

The general public.

Need for Rule:

Oregon Administrative Rules for Certified Centers, Certified Family Child Care, Registered Family Child Care and Regulated Subsidy Child Care put forth the foundational requirements to ensure the health and safety of children in care. An important component of health and safety is the safe transportation of child care children.

Policy Matters or Questions to be Addressed:

The rules and proposed rules for the safe transportation of child care children shall be reviewed and evaluated to develop foundational requirements for child care programs. Should the rules consist of guiding safety protocols when transporting children or should they prohibit the use of specific types of vehicles. The potential for fiscal and practical impact on providers who transport child care children must be considered.

Fiscal Impact [to stakeholders impacted, to small business (defined as a business that is independently owned and operated with 50 or fewer employees) or to local government]:

Fiscal impact to providers, parents of children in care, child care children and other stakeholders will be evaluated as determinations are made as to the specific rules that may be modified, repealed or added. A brief, unscientific survey was conducted in an effort to determine the potential capacity of impact.

Equity Analysis:

- **Who are the racial/ethnic and underserved groups affected?**
Those affected are the underserved communities where disparity exists in Oregon. Strength-based approaches and asset-based mindsets will support efforts to operationalize equity. The Early Learning Division recognizes that in order for each and every child and family to learn and thrive, and to have the assuredness of safe transportation while in care, we have to provide differentiated, person-centered resources and support.
- **Do the proposed rules ignore or worsen existing disparities or produce other unintended consequences?**
Specific rule language will be assessed to ensure that no barriers or unintended consequences are present.
- **What is the impact of the rules on eliminating the opportunity gap?**
The rules are intended to increase consistency of regulation enforcement across the state and among all demographics. Specific rule language will be assessed to ensure that no barriers or unintended consequences are present which could create opportunity gaps for child care providers and children in care.
- **What are the barriers to more equitable outcomes (e.g. mandated, political, emotional, financial, programmatic or managerial)?**
Barriers to more equitable outcomes may include increased costs to providers.

➤ **How have you intentionally involved stakeholders who are also members of the communities affected?**

We have developed a stakeholder engagement process that considers all potential persons and entities that may be positively or negatively impacted by any rule revisions. Part of the process is determining the most beneficial methods of engagement for each stakeholder group so that input can be gathered in a timely, mutually constructive fashion.

➤ **How will you modify or enhance strategies and rules to ensure each learner and communities' individual and cultural needs are met?**

We will take into consideration any impact, an addition or change in the transportation rules may cause providers, children and families. We will increase the training and guidance opportunities for Office of Child Care licensing staff to gain knowledge, tools and resources to better monitor and support the communities they serve.
