Early Learning Council Strategic Planning Engagement

Approach

Based on discussions from the September retreat, the Early Learning Council will engage in a strategic planning process that (a) identifies strategic priorities for the early learning and development sector, including for the 2019 legislative session; (b) engages with other sectors in order to develop a strategic plan reflective of the work in those sectors and the levers that the Early Learning Council has in supporting that work; (c) identifies the opportunities and strategies for greater cross-sector integration and (d) acknowledges shared accountability of the three system goals listed above and identifies a shared set of outcome measures for the early learning system (i.e., the early learning system dashboard). The Council's committees will need to take ownership of this identified work moving forward.

Recommended Strategy

In addition to the four sector engagement sessions conducted at the Early Learning Council meetings – Early Learning, Health, Human Services, K-12 – staff are recommending that two additional engagement sessions are conducted online, with an additional one engagement session for cross-sector partners as needed.

For Consideration: Staff request that at least one Council member attend each online engagement session and report back to the Early Learning Council.

Cross-Sector Questions

The Early Learning Council reviewed draft questions to be shared with cross-sector partners and invited stakeholders to ensure the Council receives the contextual information they need to conduct these engagement sessions in such a short timeframe. The Equity Implementation Committee has reviewed these questions and made some recommended adjustments and clarification, to assure they will apply to the variety of stakeholders being asked to come before the Council.

For Consideration: Staff request that the Council review the proposed changes to the cross-sector questions and finalize the version to be shared with stakeholders.

Ongoing Engagement

The Early Learning Division will also conduct ongoing engagement sessions throughout the summer, including work with business leaders, community-based organizations, and parents and providers. This feedback and information will be included in the strategic planning process and presented to the Early Learning Council in the fall for review.

Early Learning Council Strategic Planning Timeline

Throughout 2018, the majority of the Council's work will be engaging cross-sector partners to inform the creation of an updated Strategic Plan. As such, several meetings will primarily be dedicated to this engagement, with 3-4 hours for the first part of each meeting dedicated to engagement sessions and approximately 2 hours dedicated to Council business. *K-12, Human Services & Health may be rearranged for scheduling purposes* Additional stakeholder engagement sessions will be held online and scheduled at a later date.

Engaging other sectors in developing a strategic plan for the early learning system

Over the course of the spring, the ELC will devote 2-3 hours of each meeting to engage with all of the sectors. Each engagement session will include: (1) representation from the lead agency (e.g., OHA for health); (2) key community partners (e.g., CCOs as a health community-partner); and (3) representation from Early Learning Hubs. Lead agencies will be engaged when coordinating and inviting community partners and advocates for their respective sector session. A sample timeline and breakdown of these sessions is attached for reference.

The purpose of these engagement sessions will be to:

- 1. Deepen the ELC's understanding of these sectors, particularly the status of programs serving children birth-five and their families.
- 2. Identify key goals and outcome measures of the sector
- 3. Identify key priorities of the sector
- 4. Identify key initiative within the sector
- 5. Identify barriers to achieving the priorities
- 6. Identify what each sector needs from the other sectors in order to achieve the priorities
- 7. Identify what levers the ELC has to support the achievement of these goals, the removal of barriers and stronger cross-sector integration of the work

Within the three goals of the early learning system:

- Children arrive at school ready to succeed.
- Children live in healthy, stable and attached families.
- The early learning system is aligned, coordinated and family-centered.

Lead Agencies

Examples:

Health: Oregon Health Authority (should include public health, mental health and oral health)

Family Support: Department of Human Services (should include both Self-Sufficiency and Child Welfare)

K-12: Oregon Department of Education (should include EI/ECSE; KA; ESSA)

- 4. What resources are missing or hard to access?
- 5. What supports have been most useful to you as a parent?

- 7. What supports are most helpful to you in preparing your children for K?
- 8. What organizations or providers do you work most closely with in your communities?
- 9. What is most important to you when you are looking for care for your child?

Advocates & Philanthropy

Coordinated with cross-sector partners
