

# ADD/UPDATE HVS RECOMMENDATION (L)

#### Current Recommendation Language

- L. <u>State Leadership</u>. Leverage and expand (in some cases *streamline*) existing home visiting advisory bodies (e.g. HV Model Collaborative, MIECHV Advisory) to find efficiencies and to better represent HV program staff and those with lived experience to guide the development of a structured, comprehensive framework for home visiting that includes state/local leadership, shared goals, stable funding and paid state and regional staff
  - Likely first step is to create an action plan to move these recommendations to action

# ADD/UPDATE HVS RECOMMENDATION (L)

#### Suggestions to consider

- 1. Add "Tribal" to the header AND last line of the Recommendation
  - a) "L. <u>State and Tribal Leadership</u>."
  - b) And at the end: "... home visiting that includes state, Tribal, and local leadership..."
- 2. Add sub-bullet to (L) or a new, separate Recommendation
  - a) "Engage Early Learning Tribal Alliance at least quarterly on Home Visiting System efforts"
  - b) Use revised language in RUO 2.0 Objective 14 "Honor, recognize and ensure strong government to government relations related to the HVS efforts"
- 3. Other ideas/suggestions?

- Home Visiting Systems Recommendations throughout the draft, like
  - <u>Strategy 1.5</u> Implement a **locally developed, state supported** system to coordinate home visiting services
  - <u>Strategy 10.3</u> Build or strengthen regional structures that ensure **family leadership** in the co-creation of policies, recommendations, and strategies that guide home visiting coordination
  - <u>Strategy 10.4</u> Increase equitable access for home visitors to access reflective supervision and training on cultural competency, families with special needs children, interpersonal violence, and mental health
